Following dinner, Commodore Marla Brown called the meeting to order at 8:40 p.m.. She introduced the chef, who had prepared a truly wonderful dinner for all of us to enjoy. She thanked Shoreline YC for all their support this past year. Shoreline Commodore Mike Malbon and R/C Debbie Kraemer were introduced. C/Malbon welcomed the group and extended an invitation to come share in the events of the Trans Pac next summer hosted by Shoreline Yacht Club. SCCA officers were also introduced.

Staff Commodores introduced: Tom Collins, 1980, Bob Roth 1986, Bill Findley 1997, JD Smith 1998.

REPORTS

Treasurer Report: Suzie Scott reported the current balance is \$6,024.69 with all bills paid.

Secretary: Joanne Collins reported 15 attendees representing six yacht clubs. She noted that she would be out of the country for six months and a substitute Secretary will be needed for that period.

Rules Committee: S/C Collins discussed the missing top ten racing numbers situation. The most recent procedure was for the prior winners to turn in their numbers before the awards dinner. They would then be re-issued to the new winners. In practice, often the numbers were not turned in. One suggestion was simply to buy numbers as necessary. Another was to record the year on the Racing No. Flag for winners to keep as a memento. Tom Chandler will be contacted to discuss the suggestions.

Sanction Committee: John Willister announced that he is retiring from the Sanction Committee and John Walker will be taking over for the 2011 season.

Vice Commodore: D. Creighton passed out the Tentative Schedule for the 2011 Season. He requested suggestions on the people to contact on the question marked contests. Other suggestions welcomed.

Rear Commodore: Bill Winberg requested articles and pictures for the Skippers Log to be forwarded to him in the next week. S/C Collins suggested that some thought be given to not publishing the Skipper's Log every month, perhaps every other month or even once a quarter to help ease the burden on the R/C. Another thought was to have a permanent Skipper's Log editor, such as NACA does.

OLD BUSINESS

S/C Collins noted the need for a trophy for the Season Closer. Suzie Scott said she might have a currently unused trophy in her garage, perhaps the Pinkerton. If indeed it is found, she will bring it to the Season Closer on Sat., Oct. 16. The trophy used for the Sharkie Race is also among the missing.

A Nominating Committee has been formed. The nominations will be announced next meeting.

C/Brown adjourned the meeting at 9:00 p.m.

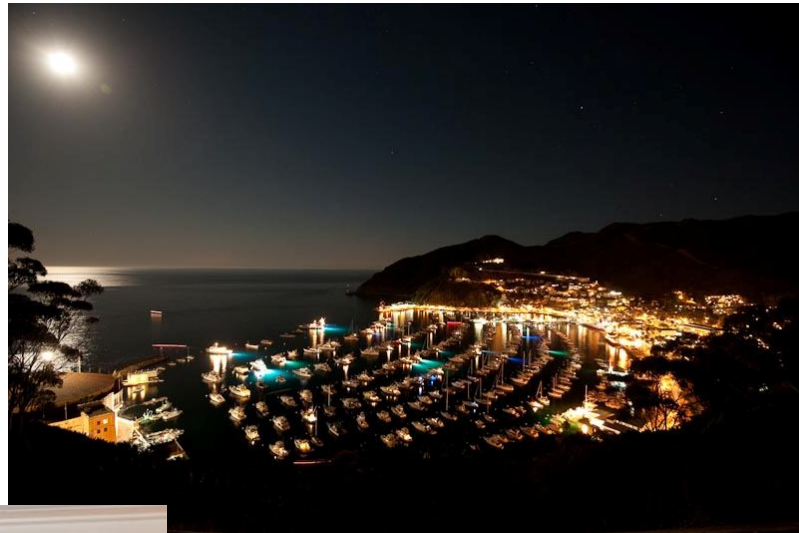


