NEW BUSINESS

The tentative 2012 SCCA schedule was presented by V/C Winberg. (Copy attached.) The Channel Islands area contests are not included because they are creating their own association – the Santa Barbara Channel Cruiser Association – SBCCA. Whether they retain membership in SCCA remains to be seen. Some discussion centered on holding the Commodores Ball in Dec. vs. Jan. January was chosen due to scheduling difficulties in December. After extended discussion, the tentative schedule was accepted with minor revision.


